Valério Arcary is a history professor at the IFSP (Federal Institute of São Paulo) since 1988. He received a Phd at USP (University of São Paulo) in 2000 with *Dangerous corners of history, revolutionary situations in Marxist perspective*. Author of *O martelo da história* (The hammer of history) 2014, among other books.

Dennis Badeen received his Ph.D from York University, Toronto, Canada, in Social and Political Thought and is currently a Marie Curie International Fellow with the Global Sustainability Institute at Anglia Ruskin University, Cambridge, UK. His research interests include: history of economic thought, methodology of heterodox and mainstream economics, Marxist political economy and philosophy, ecological economics and sociopolitical responses to climate change (with an emphasis on renewable energy and energy transitions). He has published articles in the Journal of Business Ethics, International Journal for Pluralism and Economics Education, Capital and Class, among others.

Riccardo Bellofiore is professor of Political Economy at the University of Bergamo (Italy). His research interests include capitalist contemporary economy, endogenous monetary approaches, Marxian theory and the philosophy of economics. Among his recent publications are: 'Crisis Theory and the Great Recession: A Personal Journey, from Marx to Minsky' (*Research in Political Economy*, 2011); 'Lost in Translation: Once Again on the Marx–Hegel Connection' (in *Marx's Capital and Hegel's Logic. A Reexamination*, edited by Fred Moseley and Tony Smith for Brill); 'Chrysalis

and Butterfly, Ghost and Vampire. Marx's *Capital* as the 'Gothic' Critical Political Economy of Zombie Capitalism' (in *Returns of Marxism. Marxist Theory in a Time of Crisis*, edited by Sara Farris for Haymarket books). His last books are *In Marx's Laboratory. Critical Interpretations of the Grundrisse* (co-edited with Guido Starosta and Peter Thomas for Brill, 2013); *The Great Recession and the Contradictions of Contemporary Capitalism* (co-edited with Giovanna Vertova for Edward Elgar, 2014); *Towards a New Understanding of Piero Sraffa. Insights from Archival Research* (co-edited with Scott Carter for Palgrave Macmillan, 2014); and *The Legacy of Rosa Luxemburg, Oskar Lange and Michal Kalecki* (two volumes in honour of Tadeusz Kowalik: coedited with Ewa Karwowski and Jan Toporowski, published by Palgrave Macmillan, 2014).

Jacques Bidet is Professor emeritus at the University of Paris-X. Political Philosophy and Theories of Society. His publications, on include *Que faire du Capital?* (1985), *Théorie de la modernité* (1990), *John Rawls et la théorie de la justice* (1995), *Théorie générale, Théorie du droit, de l'économie et de la politique* (1999), *Explication et reconstruction du 'Capital'* (2004), and in English, *Exploring Capital: Philosophical, Economic and Political Dimensions* (2009), *Foucault with Marx* (2016) and, edited with Stathis Kouvelakis, *Critical Companion to Contemporary Marxism* (2008).

Ivan Boldyrev, philosopher and historian of ideas, is currently a research fellow at the University Witten/

Herdecke, visiting scholar at Humboldt University (Berlin), and associate professor at Higher School of Economics (Moscow). His research interests include poetics of philosophical texts and philosophy of history. He also published widely on history of economic knowledge. Among the recent publications are *Ernst Bloch and His Contemporaries: Locating Utopian Messianism* (Bloomsbury, 2014) and (with Carsten Herrmann-Pillath) *Hegel, Institutions and Economics: Performing the Social* (Routledge, 2014). His current project is a study of dialectical imagery in Hegel's *Phenomenology of Spirit*.

Michael Heinrich is the author of „An Introduction to the Three Volumes of Karl Marx's Capital" (Monthly Review Press 2012) and „Die Wissenschaft vom Wert. Marx' Kritik der politischen Ökonomie zwischen wissenschaftlicher Revolution und klassischer Tradition (Westf. Dampfboot, Münster 2012, an English translation will appear in 2017 at Brill). Currently he prepares a three volume study „Karl Marx und die Geburt der modernen Gesellschaft. Biographie und Werkentwicklung" (Schmetterling Verlag, Stuttgart, an English translation will appear at Monthly Review Press, a French translation at éditions sociales)

Campbell Jones is Associate Professor of Sociology at the University of Auckland and a Researcher at the think tank Economic and Social Research Aotearoa (ESRA).

Kojin Karatani is one of the most influential contemporary Japanese intellectuals. After obtaining BA in economics

from University of Tokyo, he made a sensational debut as a literally critic. He has published over dozens of books since then, covering varieties of fields, providing most original and synthetic theories. Among them the following are translated into English; *Origins of Japanese Literature* (Duke), *Architecture as Metaphor* (MIT), *Transcritique --Kant and Marx* (MIT), *History and Repetition* (Columbia UP), and *Structure of World History* (Duke). *Origins of philosophy* (Duke), *Nation and Aesthetics—Kant and Freud* (Oxford UP) and *Marx, the Center of its Possibilities* (Verso) are scheduled for publication. He was a visiting professor at Yale, Columbia, Cornell, and UCLA.

Ognian Kassabov teaches philosophy at Sofia University, Bulgaria. His main research interests lie in the history of aesthetics, Kant and German Idealism, as well as the roots of Marxist thought in modern philosophy and political theory. He has published the book *Техника на природата, органика на изкуството* (*Technique of Nature, Organics of Art*; in Bulgarian, 2014).

Andrew Kliman, a professor emeritus of economics at Pace University in New York, is the author of two books, *Reclaiming Marx's 'Capital'* and *The Failure of Capitalist Production*, as well as dozens of papers on value theory, economic crisis, income distribution, and other topics. Politically, he works with Marxist-Humanist Initiative and writes frequently for its web journal, *With Sober Senses* (www.marxisthumanistinitiative.org/ our-publication).

Elena Louisa Lange is Senior Research Associate and Senior Lecturer at the Institute

for Asian and Oriental studies, University of Zurich. Since 2009, Lange has been teaching classes on intellectual history, Japanese philosophy, Marxism and modernity. She has co-edited books on modern Japanese philosophy (Begriff und Bild der modernen japanischen Philosophie, frommann-holzboog 2014 and What Is Philosophy?, Brill, forthcoming in 2017), published articles on recent debates in Marxian value theory, and is currently working on a critical study of Japanese Marxist Uno K z . She is advisory board member of the SAGE Handbook in Critical Theory and regularly gives lectures and conducts workshops on Marx's *Capital*.

Frédéric Lordon is director of research at the CNRS (CESSP-CSE, EHESS). His research program named "structuralism of passions" consists in a spinozian political economy, emphasizing the role of affects and desires in the institutions of capitalism: money, finance, work relationships, the State, etc. He has published in english *Willing slaves of capital. Marx and Spinoza on desire* (Verso, 2014) and *Imperium. Structures and affects of the political bodies* (Verso, forthcoming).

Patrick Murray is professor of philosophy and the John C. Kenefick Faculty Chair in the Humanities at Creighton University. He is author of *Marx's Theory of Scientific Knowledge* (1988) and editor of *Reflections on Commercial Life* (1997). A collection of his essays on Marx, *The Mismeasure of Wealth: Essays on Marx and Social Form*, was published in 2016 by Brill in the book series of the journal *Historical Materialism*. He is working on a book on Marxian social

theory under the title *Capital's Reach: How Capital Shapes and Subsumes*. His research interests center on the relation between capitalism and modern philosophy and include the British empiricists, Hegel, Marx, and the Frankfurt School. With Jeanne Schuler, he is completing a book of essays entitled *False Moves: Basic Problems with Philosophy*; it is a study of the ways in which dualisms between the subjective and the objective breed skepticism.

David Pavón-Cuéllar is Professor of Marxism, Critical Psychology and Lacanian Psychoanalysis at the State University of Michoacán (Universidad Michoacana de San Nicolás de Hidalgo, Morelia, Mexico). He has taught at the Universities of Paris 8, Porto, Chile, Vale do Rio do Sinos, Querétaro, Tijuana and others. He holds a PhD in Philosophy from the University of Rouen, and a PhD in Psychology from the University of Santiago de Compostela. His books include *Marxisme lacanien* (Paris, Psychophores, 2009), *From the Conscious Interior to an Exterior Unconscious: Lacan, Discourse Analysis and Social Psychology* (London, Karnac, 2010), *Elementos políticos de marxismo lacaniano* (Mexico, Paradiso, 2014), and *Marxism and Psychoanalysis: In or Against Psychology?* (London, Routledge, 2017, forthcoming). He co-edited, with Ian Parker, *Lacan, Discourse, Event: New Psychoanalytic Approaches to Textual Indeterminacy* (London & New York, Routledge, 2013), and recently, with Nadir Lara, *De la Pulsión de Muerte a la Represión de Estado: Marxismo y Psicoanálisis ante la Violencia Estructural del Capitalismo* (Mexico, Porrúa, 2016). He belongs

to the Editorial Boards of *Annual Review of Critical Psychology*, *Psychotherapy and Politics International*, *Teoría y Crítica de la Psicología*, *Macerata*, *Quodlibet*, *Educación*, *Política y Sociedad*.

Moishe Postone teaches history and social theory at the University of Chicago, having received his Dr.Phil. from the J.W.Goethe-Universität in Frankfurt, under the supervision of firing Fetcher. He has published extensively on Marx — *Time, Labor, and Social Domination* — as well as on Critical Theory, problems of antisemitism, and contemporary historical transformations.

Jason Read is Associate Professor of Philosophy at the University of Southern Maine. He teaches courses in the history of political philosophy, contemporary social theory, the politics of work, and the philosophy of film. He is the author of *The Micro-Politics of Capital: Marx and the Prehistory of the Present* (SUNY 2003) and *The Politics of Transindividuality* (Brill/ Haymarket 2015/16) as well as articles on Althusser, Deleuze, Spinoza, Hegel, Negri, and The Wire. She is honorary fellow of the International Institute for Social History, where she co-coordinates the international project 'In the Same Boat?
